2014 LEGISLATIVE WRAP-UP

SUPPLEMENTAL OPERATING BUDGET

Postsecondary Education

Opportunity Scholarship Program - \$25.35 Million to expand the scholarships available and match additional private contributions received.

College Bound Scholarship - \$12.2 Million (Caseload Funding) to reflect new caseload estimates for the College Bound Scholarship program.

State Need Grant - \$5 Million additional funding per SB 6523 for Fiscal Year 2015 for student financial aid payments in the State Need Grant program.

SNG Awards at For-Profit Institutions – Removes the 50 percent reduction in SNG award amounts for students attending for-profit institutions that has been in place since the 2011-12 academic year.

Resident Undergraduate Tuition – No increases for 2014-15 academic year.

Employment Data for Higher Education Completers - \$46,000 for the Education Research & Data Center to collect and publish short- and long-term earnings and employment data for completers of higher education degrees, apprenticeships, and certificates.

Higher Education Audit - \$300,000 for the Office of the State Auditor for an audit of the dedicated local and operating fee accounts of the state's institutions of higher education to improve accounting practices, transparency, and accuracy.

- Year-Up Model \$350,000
- Paraeducator Development/Implementation of SSB 6129 \$13,000
- MESA Programs \$410,000

University of Washington: Institute of Protein Design - \$1 million

Closing the Opportunity Gap-\$245,000 in one-time funding to the SIP and the PESB for a variety of strategies to close the opportunity gap.

Council's Priorities for 2014 Session

- Fully fund College Bound Scholarship.
 - \$12 million to serve all 8,000 eligible students in FY 14-15
- Increase students served by the State Need Grant program.
 - \$16 million to increase number by 3,800 for FY 14-15
- Adopt educational attainment goals for 2023.
- Support legislation aligned with Roadmap priorities.
- Eliminate unnecessary or duplicative state regulatory requirements.

Council-Supported Bills Passed

HB 2626—Concerning Statewide Educational Attainment Goals.
