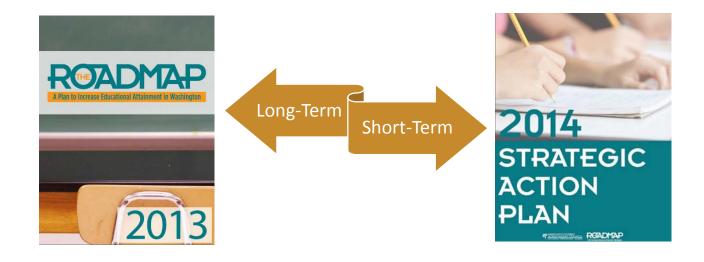

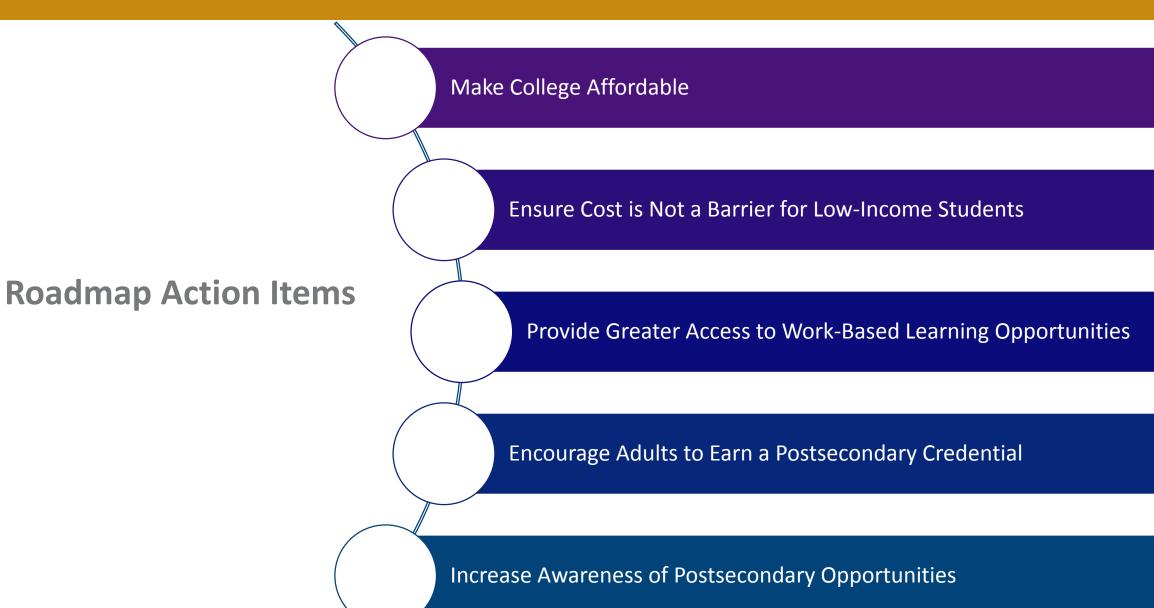

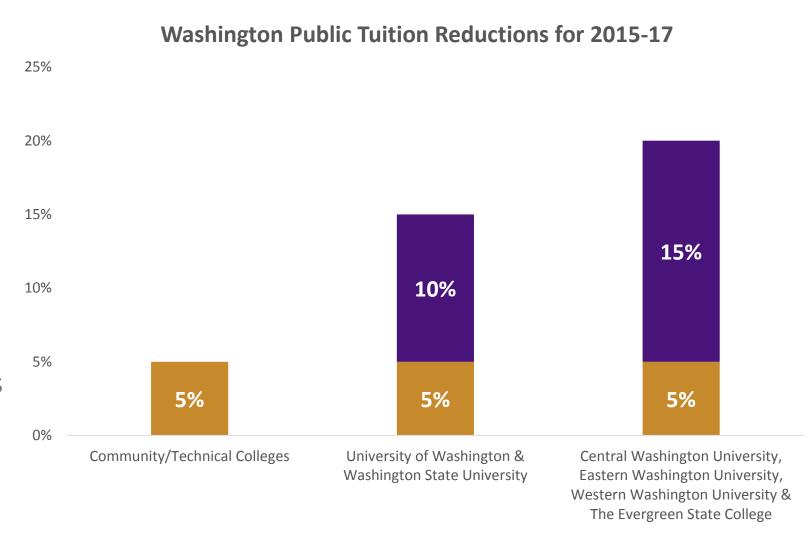

- The College Affordability Program (SB 5954) provides an opportunity to provide continued funding to institutions to support students and leverage investments to make significant progress toward Roadmap goals.



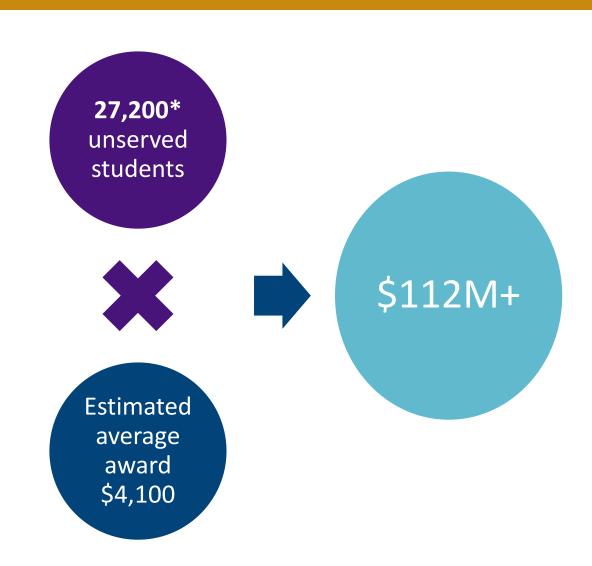

#### Ensure Cost is Not a Barrier.



- In 2014-15, 2/3 of eligible students were served (71,000) by **State Need Grant**.
- Over 100,500 eligible students enrolled in 2014-15.
- \$56M would close the gap in two years.
- \$37M would close the gap in three years.
- \$19M would close the gap in six years.



\*Estimates reduced by College Bound funding transferred to SNG to offset priority for State Need Grant.

#### Ensure Cost is Not a Barrier.





- The College Bound Scholarship is considered "maintenance" level as a Caseload Forecasted program.
- College Bound students receive priority in State Need Grant and funding has been provided to ensure served students are not displaced.

#### Access to Work-Based Learning.



- State Work Study provides work-based learning opportunities to students.
- Work study experiences improve academic and employment outcomes.
- Partnering with nearly 1,000 employers, 4,400 students earned \$12.2M in 2013-14, including \$4.8M in employer contributions.
- \$5M in state funding would leverage an additional \$2M in employer contributions.

# As the program administrator for the **College Bound Scholarship**, WSAC:

- Identifies eligible students and promotes the program.
- Manages the application system.
- Communicates with students, families, schools, and partners.
- Shares data with schools, partners, and researchers.
- Monitors student eligibility.
- Provides automated tools to schools and partners.



\$400,000 would permit the development of a high school toolbox, enhance communication strategies, and implement training modules for partners.

#### **Encourage Adults**



**Re-engagement** strategies are needed to identify and support adult students.

950,000 adults with some college.



715,000 not enrolled in college.



460,000 earning less than a living wage.

\$500,000 to develop a statewide approach to identify students with some college and no degree and provide them with degree completion options so they can successfully reach their educational goals.
